The similarity of the Tenderer's participation shall be based on the physical size of at least 50 MMSCFD capacity high pressure (350 psig or above) gas Metering Station (MS)/City Gate Station (CGS)/Regulating & Metering Station (RMS)/Town Border Station (TBS), Gas regulating/metering station with procurement and installation scope of works.- In case of JVCA, the proposed Partner-in-Charge/Lead Firm from outside Purchaser's/Employer's country shall meet the requirements as stated under 14.1 (b) (i) above and the partner(s) from outside purchaser's/Employer's country or partner(s) from Employer's country shall have experience of installation gas metering/regulating station works.
